Preparing for your Parenting Plan Mediation

Steps to a Child-Centered and Successful Process

I look forward to assisting you with your parenting plan mediation process. A parenting plan is by far one of the most important documents you will craft together and contracts you will sign. The outcome will guide your children's lives in their two-home family for years to come. Your co-parenting relationship will be a foundational part of this agreement. Your children's health and well-being is likely directly correlated with your level of co-parenting skillfulness. As you begin making parenting plan decisions, remember that you will be co-parents "until death do you part" regardless of the stress and disappointment you may currently be experiencing as a result of ending your intimate partnership. Friendship is not important; respect, civility and child-centered two-home parenting *is*.

To prepare, please know there are many assets on the website to assist you:

- "The Parenting Plan Workbook" is a guidebook to creating a child-centered parenting plan. You will find insights and inspirations provided by 25 family law professionals in support of a family-centered divorce process from around the globe. There are pages for journal moments to help you capture your own thoughts and dig deeper into the important considerations for your parenting plan. And most importantly, parenting plan worksheets that will assist in helping you understand how to think about what goes into a parenting plan.
